

SHELTER WA's RECENT ACTIVITIES AND EVENTS

Western Australian NGO Affordable Housing Stakeholder Alliance:

Shelter WA (SWA) together with the Tenants Advice Service (TAS) and the Community Housing Coalition of WA (CHCWA) held a consultation and engagement forum/workshop on the 12th October 2010.

We have been progressing this work internally and looking at implementing the suggestions that were made for stronger collaboration and integration between us and our membership and networks. We have also clarified and strengthened links with the WA Council on Homelessness and our voice and role in the Housing Advisory Roundtable (HART) convened by the Department of Housing.

Please find below a brief synopsis of where we are at and what will be happening in weeks to come.

Outcomes and key points from 12 October 2010 meeting:

- Information sources are multiple and adequate
- Opportunities to have input into government policy development and evaluation is currently limited or non-existent
- Not enough time given to consultation and engagement process by government
- Smaller organisations don't feel adequately represented or that they "have a voice" or capacity to advocate, unlike larger organisations with direct links to government who are often approached by government for input
- Need for peaks to communicate more effectively with member organisations and coordinate actions and responses
- Peaks need to be working at a ministerial level
- Need to strengthen existing structures rather than creating something new

Since the meeting on 12/10/11 the NGO Alliance Key Stakeholders have:

- Met with Anna Paris from the WA Council on Homelessness (WACH) to forge stronger links, understand the terms of reference of the WACH and explore integration, opportunities for input and information sharing;
- Discussed a variety of issues & policy engagement at Housing Advisory Roundtable (HART) meeting 1/11/10
- Been notified that the State Affordable Housing Strategy is scheduled to be released in December 2010.

Where to from here / future actions:

Currently SWA, CHCWA and TAS are formulating an action plan to guide the efforts of the NGO Housing Alliance. Some actions include:

- NGO Housing Alliance Key Stakeholders (SWA, TAS, CHCWA and WACOSS) will meet regularly to coordinate input to relevant committees, including the Housing Advisory Roundtable.
- Alliance Stakeholder organisations to improve processes for consultation with members and provide more opportunities for involvement – invitation in electronic communications for network members to identify practical and service issues, implementation progress, linkages
- Development of the NGO Housing Alliance aims, scope, purpose and terms of reference
- Generate a timeline with key events and dates for the NGO Housing Alliance to be prepared to collectively respond to; these include:
 - Release of State Affordable Housing Strategy - December 2010
 - Review of the Residential Tenancies Act 1987 (RTA) anticipated for 2011
 - Next HART meeting (January 2011) and prior to each meeting to inform HART agenda
 - WA Council on Homelessness (State Plan - Opening Doors)

National Shelter Meeting Hobart November 26-27

The State and Territory Shelter organisation Executive Officers recently came together in Tasmania for our National Shelter face-to-face and AGM. Western Australia continues to perform well against the other states in regards implementing the reforms, new services and initiatives of the National Partnership Agreements on Social Housing and Homelessness, with WA one of only a small number of State and Territory jurisdiction to have fulfilled the upgrades, new buildings and renovation targets and deadlines set by FaHCSIA under these funding agreements.

National Shelter work over the coming year 2011-2012 will include:

- Looking at rent setting models and frameworks in public and community housing, nationally and state-by-state
- Exploring the regulation and registration of Community Housing Organisations and monitoring the form that a nationally consistent regulatory system may take – following the FaHCSIA consultation around regulation of Community Housing Organisations that closed in June 2010
- Monitoring and supporting work to strengthen state based Residential Tenancies Legislation toward a nationally consistent consumer protection framework
- Completing a national project looking at Marginal Tenancies across the country – including the variety of models addressing security of tenure issues for caravan park residents, boarders, lodgers and rooming house tenants.
- Monitoring the data collection model to be introduced that will replace SMART (the NDCA minimum data set for former SAAP services)
- Revisiting the tax review paper of 2009 (the Henry Report), to explore taxation models and consequent implications in relation to the way housing is treated in the Australian Tax System.
- Monitoring the 2011 Census preparation and implementation regarding **'Counting the Homeless'** as this data and the definitions of homelessness (Primary, Secondary and Tertiary) will have a direct bearing of number evidence for States reporting against homelessness reduction targets identified in the NPA's Homelessness and Social Housing.
- Monitoring the work being done with Homelessness Australia around 'exits to homelessness' particularly from health facilities – hospitals, psychiatric units, corrections and incarceration facilities and Child Protection services (foster care and out-of-home care services)

Exploring Consumer Protections for WA's Boarders & Lodgers

Shelter WA is working with TAS and a number of other agencies progress work toward the reform and strengthening of consumer protections for Western Australian citizens who are in tenures identifying them as Boarders and Lodgers. In WA there is no consumer protections for these people and very little by way of ensuring adequate standards of facilities in premises and buildings that operate in this way. We are aware of several residential houses in inner city and middle ring suburbs that house 6 or more unrelated individuals that are neither registered by the local government authority, nor any other state jurisdiction, and that pose significant consumer protection and safety concerns for the vulnerable people they house. International students are a particular cohort who is accommodated in these unregulated forms of tenure, and for whom the certainty of lease agreements and minimum conditions would greatly improve their ability to study in WA and contribute financially to the economy and community.

At a recent meeting of the Boarders and Lodgers working group it was agreed that:

- Legislative Reform is the main objective of the working group
- Need to balance the interests of both consumers and providers of boarders and lodgers accommodation.
- Working group is concerned that having too many objectives may hinder the progress/focus of the working group. Looking into supply may also involve more organisations which includes department of housing, department of planning.
- The question of supply of additional housing needs more debate. It should be ancillary to the main objective, which is Legislative Reform. "Supply issues" will be a consideration by the working group and not an objective.
- The Fair Trading Act provides for the enforcement of compulsory codes of conduct for certain industries. There can be other reforms done to charters/regulations/best practices/building standards.

Important Consumer Protection Legislation

Two important pieces of legislation passed through the Western Australian State Parliament on Thursday 25 November 2010 that will have a fundamental impact on consumer protection laws and administration in Western Australia.

Fair Trading Bill 2010 (WA)

The first piece of legislation is the Fair Trading Bill 2010 (WA). The Fair Trading Bill 2010 (WA) still needs to receive Royal Assent to become an Act and a proclamation is then required to bring this Act into operation, however, it is intended that these actions will be completed in time for the *Fair Trading Act 2010 (WA)* to come into operation in Western Australia on 1 January 2011.

The Commonwealth's Australian Consumer Law will also come into operation on 1 January 2011.

The Fair Trading Bill 2010 was amended during its passage through the Legislative Council and, therefore, the Bill is in some respects different to the Bill which the Government introduced into Parliament on 22 September 2010.

The *Fair Trading Act 2010 (WA)* will achieve the following three key outcomes:

- a) it will implement the new, nationally uniform Australian Consumer Law in Western Australia as the Australian Consumer Law (WA);
- b) it will replace the current *Consumer Affairs Act 1971 (WA)*, the *Door to Door Trading Act 1987 (WA)* and the *Fair Trading Act 1987 (WA)*; and
- c) it will continue the role of Commissioner for Consumer Protection; however it makes a number of changes to the powers of the Commissioner.

The Act provides that the Australian Consumer Law as set out in Schedule 2 to the Commonwealth's *Competition and*

Consumer Act 2010 (the re-named *Trade Practices Act 1974*) as in force when the Act commences, will apply as a law of Western Australia, to be known as the Australian Consumer Law (WA).

Future amendments to Schedule 2 to the Commonwealth's *Competition and Consumer Act 2010* made by the Commonwealth, will not apply in Western Australia unless and until separate amendments are made to the *Fair Trading Act 2010 (WA)* to apply those Commonwealth amendments as a law of Western Australia.

Regulations relevant to the Commonwealth's Australian Consumer Law will automatically apply in Western Australia but they will be subject to disallowance by the Western Australian Parliament as if they were regulations made in Western Australia.

The Australian Consumer Law (WA) effectively replaces the consumer protection laws currently contained in the *Fair Trading Act 1987 (WA)* and the *Door to Door Trading Act 1987 (WA)* and the product safety laws currently contained in both the *Consumer Affairs Act 1971 (WA)* and the *Fair Trading Act 1987 (WA)*. Much of the existing law is retained and will be familiar to those who are familiar with the current laws. However, there are a number of important new provisions in the Australian Consumer Law. These include:

- entirely new provisions relating to unfair contract terms;
- new provisions in relation to "consumer guarantees", which replace, with enhancements, existing provisions relating to implied conditions and statutory warranties;
- changes to the unconscionable conduct provisions;
- specific new provisions regulating false and misleading representations in relation to testimonials and statutory consumer guarantees;
- new obligations for those traders that offer rebates, gifts, prizes etc;
- new obligations for traders in relation to accepting payment in advance for goods and services;
- a new, express protection for consumers from any obligation to pay for unsolicited services;
- where goods have more than one displayed price, traders will be under a new obligation to sell the goods at the lowest price or withdraw the item from sale;
- new obligations for traders in relation to the advertising of goods or services to include a single price, including taxes and other charges;
- new requirements in relation to lay by agreements, including an obligation on traders to provide written lay by agreements;
- a new obligation on traders to provide consumers with receipts for purchases of goods or services over \$75 and a right for consumers to require a receipt (within a reasonable timeframe) for goods or services less than \$75;
- a new right for consumers to require traders to provide an itemised bill for any services; and

- some documents required to be provided by traders to consumers will need to be "transparent", requiring them to be expressed in clear language, be legible and be presented clearly.

The existing door to door trading laws will be replaced by new laws covering "unsolicited consumer agreements", which include both door to door transactions and, in certain circumstances, telephone sales.

Product safety laws will remain essentially the same, however, the administration of product safety laws will be subject to some changes, including that only the Commonwealth Minister will be able to make safety standards for consumer goods or product related services and only the Commonwealth Minister will be able to impose a permanent ban on consumer goods or product related services.

Maximum penalties have been increased and there are a range of new remedies and enforcement actions provided for, including civil pecuniary penalties and substantiation notices.

The *Fair Trading Act 2010 (WA)* preserves the power to make State specific codes of practice, and continues on the existing codes of practice in place for the retirement village industry and the fitness industry. There are, however, some changes to the way in which such codes are made and enforced.

The *Fair Trading Act 2010 (WA)* continues the role of Commissioner for Consumer Protection, however it makes a number of changes to the powers of the Commissioner. The most important of these is that the Commissioner will have a new power to institute or defend legal proceedings on behalf of a business where a matter of public interest is involved.

Acts Amendment (Fair Trading) Bill 2010 (WA)

The second piece of legislation is the Acts Amendment (Fair Trading) Bill 2010 (WA).

This Bill contains a number of amendments that are consequential to the enactment of the Fair Trading Act 2010 (WA) but it also contains important changes to occupational licensing within the Consumer Protection portfolio.

The Acts Amendment (Fair Trading) Bill 2010 (WA) also still needs to receive Royal Assent to become an Act and a proclamation is then required to bring this Act into operation, however, it is intended that these actions will be completed in time for the provisions relevant to the *Fair Trading Act 2010 (WA)* to come into operation in Western Australia on 1 January 2011. Other provisions will come into operation later in 2011.

The most significant changes contained in this Bill are those that will transfer the functions of four statutory licensing boards to the Commissioner for Consumer Protection and the Department of Commerce.

The licensing boards affected are: the Land Valuers Licensing Board, the Motor Vehicle Industry Board, the Real Estate and Business Agents Supervisory Board and the Settlement Agents Supervisory Board.

The licensing functions of these boards will be vested in the Commissioner for Consumer Protection. The employing and

financial responsibilities of these boards will be vested in the Director General of the Department of Commerce.

To preserve industry input into the licensing functions, the Bill will establish a Motor Vehicle Industry Advisory Committee and a Property Industry Advisory Committee. In addition, the Bill establishes a new Consumer Advisory Committee to provide general advice to the Minister and the Commissioner for Consumer Protection.

It is currently intended that the licensing boards affected by this Bill will be wound up on 30 June 2011. It is expected that the new advisory committees will come into operation in the first half of 2011.

The other significant change to licensing implemented by this Bill relates to motor vehicle dealing. The Bill inserts a new deeming provision into the Motor Vehicle Dealers Act 1973 (WA) that will provide a rebuttable statutory presumption that a person who sells or exchanges four or more motor vehicles in a 12 month period is carrying on the business of dealing in motor vehicles and, therefore, will be required to be a licensed motor vehicle dealer. A range of exemptions will be prescribed by regulations to avoid capturing persons such as legitimate collectors. It is expected that these new provisions will come into operation in the first half of 2011.

These two pieces of legislation represent fundamental changes to consumer laws and administration in Western Australia.

Stakeholders affected by these laws may need to seek separate advice on the implications of the changes on their activities.

The Department of Commerce and the relevant licensing boards will provide more information on the changes in the coming weeks and months.

Friday, 26 November 2010 SENATE 67. The following answers to questions were circulated:

Families, Housing, Community Services and Indigenous Affairs: Program Funding **Senator Scullion** asked the Minister representing the Minister for Families, Housing, Community Services and Indigenous Affairs, upon notice, on 15 March 2010: With reference to the Council of Australian Governments' resolution to renegotiate the funding arrangements pertaining to the National Partnership Agreement on Remote Indigenous Housing, as at 1 March 2010:

- a) what funding has been provided to each state and territory government through this agreement; and
- b) how many houses have been constructed by each state and territory government through this agreement.

Senator Arbib—The Minister for Families, Housing, Community Services and Indigenous Affairs has provided the following answer to the Honourable Senator's question:

- a) The National Partnership Agreement on Remote Indigenous Housing (NPARIH) provides a total national allocation of \$5.5 billion over the period of the agreement. The actual total allocations for each state and territory are subject to an ongoing competitive bids process subject to delivery of new house, rebuild and refurbishment targets.
- b) In 2009-10, 316 new houses and 828 refurbishments were delivered across Australia (see table below). As at 22 October 2010, the most recent reports by jurisdictions stated that a further 36 new houses and 358 refurbishments have been delivered under the NPARIH this financial year and 165 new houses and 338 refurbishments are also underway.

WAAC: WA Sexual Health Week - Community Small Grants

WA Sexual Health Week 2011 will run from Monday 14 February until Sunday 20 February 2011. The ongoing theme for WA Sexual Health Week is *'Safety, Pleasure and Respect'*. The target group for 2011 is youth aged 15 – 24 years.

For this reason, the WA Sexual Health Week Committee is providing a Community Small Grants Scheme. This will enable health promotion officers, public and community health nurses, Aboriginal health workers or other relevant personnel and youth-oriented organisations in regional/remote WA to apply for financial assistance (grants up to the value of \$500 each) from the WA Sexual Health Week Committee to contribute to hosting a small event in their community.

Ruah Community Services: Intensive Housing Support Program

The Housing Support program is directed at adults and young people (16 years plus) with severe and persistent mental illness who are residing in Specialist Mental Health Inpatient Units of Graylands Psychiatric Hospital, Bentley Clinic, RPH Psychiatric Unit, Sir Charles Gairdner Hospital (ward D20), and Armadale Hospital.

The Housing Support program offers fast tracked Department of Housing accommodation, and assists individuals in obtaining alternative forms of long-term accommodation options after assessing their needs and situation. Brokerage funding is available to assist individuals with essential household furniture. A community case manager provides ongoing links to support services for 12-months after independent accommodation is secured (9 months direct work and 3 months follow-up phone contact). Referrals can be made through the psychiatric inpatient units via the Social Work Departments. There is no waitlist for this program. Referrals are accepted during designated intake periods.

There are many people, in many agencies, working diligently to meet the needs and aspirations of Aboriginal people (and others) within Armadale. It can be frustrating. Sometimes there's just not enough time in the day. And yet many times we don't achieve as much as is needed.

In the mean time many Aboriginal people and (extended) families face a range of issues in their lives. They are confronted with a complex maze of services, and it can be difficult and often stressful navigating this maze. Sometimes people can 'fall through the cracks' of support that is available.

The City of Armadale's Champion Centre in collaboration with the Aboriginal Affairs Coordinating Committee which comprises The Department for Child Protection, WA Police and the departments of Indigenous Affairs, Education, Health and Housing is creating a 'One Stop Shop' that is seeking to develop a more effective relationship between Aboriginal residents and services. This is based on an understanding that the key is not to develop more and more services, but to make sure that the services that are already here are able to work together in maximising their effectiveness.

This is great in theory. But how do we really make effective collaboration throughout the sector happen? This forum will allow participants to explore that question.

Call for Papers for the 2011 National Indigenous Domestic Violence Conference to be held at Sea World Resort, Gold Coast, Australia on May 17-19, 2011

Following the successful staging of the Global Domestic Violence Conference in Kuala Lumpur, Malaysia, it was decided that a national indigenous conference be organized in Australia. One of the highlights of the event was the presentation by Mr. Hughie Pepper, an Indigenous Australian and Dr. Chris Laming of Monash University whom presented a keynote on 'Engaging Australian Indigenous Men to Stop Violence'.

Hughie Pepper is an Aboriginal man of the Gunnai Kurnai people of Gippsland. He is a community leader, enormously respected. Hughie is the 'go to' person, highly regarded by both mainstream and indigenous workers alike, because of his integrity, genuineness and ability to quietly get things done. By developing programs in conjunction with others whilst taking a holistic approach to combating domestic violence within his community, Mr. Pepper outlined his work that bridges and links two worlds, the Koorie and non-aboriginal people in his area. In his presentation, he further outlined the work within the Regional Indigenous men's behaviour. Furthermore, his work as case manager based at the Latrobe Community Health Service proven to be a leading factor in combating domestic violence within the whole region, working and facilitating men's behaviour change groups for more than ten years.

Because of his Aboriginality and his status, based on who he is and how he is, Hughie Pepper has been able to challenge those men in the Aboriginal community who are abusive. It was quite clear from Mr. Pepper's presentation and soon become apparent that he is a role model for young men and boys and demonstrates how he straddle two worlds, whilst keeping his sense of humour and his feet on the ground. Delegates at the conference were impressed with the presentation, the approach that Mr. Pepper's team and community were taking to overcome domestic violence in his area.

Indigenous people from throughout Australia should take pride and feel proud of the many of successful projects to overcome family violence in the country. From an Indigenous point of view, Australia is one of the leading countries in overcoming domestic violence, placing Indigenous Australians at the full front of the battle. One of the things that emerged from the conference was the need for further development of the global coalition's network and to further engage indigenous input into the coalition. To this end, a series of smaller conferences will be held throughout the world, devoted to indigenous domestic violence issues within local communities.

The 2011 National Indigenous Australian Domestic Violence Conference is scheduled to be held at the Sea World Resort in the Gold Coast. Planning is in the early stages however, the date will be on 17-19th of May 2011. The conference will focus on increasing awareness of programs being delivered throughout Australia and some parts of the world. One of

Flinders University 2010 Homelessness Research Project
